It easily removes soap scum, urine, hard water deposits, rust, scale, lime, mildew and general bathroom soils. Contains no corrosive acids and no bleach.

DIRECTIONS FOR USE: For best results, apply directly onto soiled surface (including under toilet rim) and wipe or spread using a sponge, mop, bowl brush, scouring pad or cloth. Rinse thoroughly with water. For hard to remove stains allow for longer contact time before wiping, repeat as necessary.

NOTE: Test on an inconspicuous area prior to use. Do not use on marble or limestone. All surfaces subject to direct food contact must be thoroughly rinsed with potable water before reuse.

STORAGE: Keep in a tightly sealed container in a well ventilated room. Do not store with food products. Keep from freezing.
